Q: Why are you running for RTM?

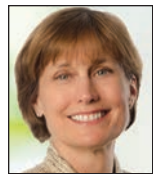

The NEC High Speed rail line will be a disaster if the Town cannot muscle the ammunition to fight its proposed location. 3] Traffic and the lack of civility it provokes create worsening dangerous conditions Townwide.
